Conservation - Zambia is the 'Crossroads for Connectivity'. It borders 8 different countries, connects Eastern and Southern African populations, shares 4 transfrontier conservation areas, and has over 30% of its land managed for wildlife uses.

To date, the biggest threat to African wildlife in South Luangwa Valley, Zambia, is poaching. African elephants are poached for their tusks and sometimes skin, lions for their bones and other animals, such as endangered wild dogs are unintended victims of poaching because of indiscriminate wire snaring.
